

Cookiestatement Markerink

Reparatie-, Installatie- en Garagebedrijf Markerink B.V. (KvK 09050440), hereinafter referred to as "Markerink" uses cookies. In this cookie statement you can read what cookies are, for what purposes we use them and which cookies we place.

What are cookies?

Cookies and cookie-like technologies are small text files that are stored in your browser when you visit and use our website. These text files may contain information about your (previous) use of the website and certain choices and settings that you decided upon. In addition, cookies are used to identify your computer.

Why do we use cookies?

We automatically collect and process data on our websites using cookies and cookie-like technologies to track the behavior of visitors to our websites. This helps us to optimize our websites and adapt them to the interests of our visitors.

1. Functional cookies

Functional cookies ensure that our website functions properly and you can easily use the site. These cookies are also necessary for the proper technical functioning of our website. The use of these cookies does not require permission from you as a visitor to the Markerink website. The software on which our website runs uses the following cookies, which we use for the following purposes:

2. Analytical cookies

We also use analytical cookies to give us insight into the information needs and interests of our visitors. This allows us, for instance, to see how, when and with which browser you visit our website. We use Google Analytics for this. Google Analytics uses this information to keep track of how you use the website, to prepare reports on website activity and to offer other services with regard to website activity and internet use. The analytical cookies we use have little or no effect on your privacy. We use this information to optimize our websites and to be able to offer targeted and relevant content. We use the following analytical cookies for the following purpose:

3. Marketing cookies
